**Warming Weather Brings Out Home Improvement Con Artists**

The Montgomery County Police would like to remind members of the community to be on the lookout for unlicensed home improvement contractors. As the weather warms up, the activities of so called “woodchucks” increase. “Woodchucks” are scam artists who generally target our elderly residents. These individuals will approach a victim and tell them that their trees need to be trimmed or removed. Then they will pressure the victim into paying thousands of dollars to have a few tree branches removed. The “woodchucks” then continue to tell the victim that their roof is leaking and scam the victim out of thousands of dollars.

Recently, there have been several high profile cases involving fraudulent contractors who have conned residents out of hundreds of thousands of dollars. In one case, the victim lost \$90,000 dollars, in another case, the victim lost \$82,500 dollars, and in yet another case, the victim was lucky and only lost \$3,000 dollars.

The unlicensed home improvement contractors will drive through neighborhoods looking for elderly residents or cars with handicapped license plates on them. They will then approach the house and try to solicit business. Several clues that a fraudulent contractor is present include saying things like “we have material left over from another job in the area and can give you a real good price.” When a contractor tells the victim that they must pay half or all of the cost of the job up front, this is also a clue that they are fraudulent. Maryland state law states that a contractor may not charge more than 33% of the total cost of the job as a down payment.

**Door-to-Door Sales License Required in Montgomery County**

A door-to-door vendor's license is required of all individuals traveling from dwelling-to-dwelling, or from office-to-office to sell goods or services in Montgomery County. This license is issued by the Department of Permitting Services (DPS) and has a photo identification of the vendor. If a door-to-door sales person comes to your door, ask to see his/her vendor's license along with his company identification before entertaining any discussion. If the person is selling something for immediate delivery or taking funds for future delivery, a bond is also required. Please make sure that all door-to-door vendors are licensed, for your sake and your neighbors safety too!

If the vendor is not properly licensed, you can contact the Montgomery County Police non-emergency number 301-279-8000 for further action, or inform the Permit Technician at the DPS at 240-777-6386. Provide the company's name and business location to DPS. **If you are concerned that the vendor is fraudulent, or suspicious, CALL the Police!** When you call the police, please have all relevant information possible: description of the person, make/model of the car, and direction of travel.
