## November HCA Community Meeting

The next Community Meeting for the Hillandale Citizens Association will be held at CHI on Thursday, November, 16<sup>th</sup>. Our special guests will be Maryland State Delegates Jheanelle Wilkins and Sheila Hixon who will answer questions and respond to our concerns. ## Short-Term Rentals in MC

Effective July 1, 2018, Montgomery County will legalize the short-term rental (occupancy of fewer than 30 days) of rooms in all areas. Those wishing to rent rooms under this program will have to be licensed by the County, pay "hotel taxes," and abide by various requirements. The executive regulations providing the details will be written and approved in early 2018 with a licensing procedure launched before the effective date. Below is a summary of the basic points in the expected rules:

1. Only primary residents of a home can rent it out.
2. Short-term rentals are not allowed in accessory apartments.
3. If the owner is absent, residents can be rented out for a maximum of 120 days per calendar year.
4. The maximum number of adult overnight guests per short-term rental is six and the maximum number of adults per bedroom is two.
5. Property owners must apply for a license to use their homes as short-term rentals with the county's Department of Health and Human Services.
6. To obtain a license, owners must notify immediate

neighbors and their homeowner's association, if there are any, that they plan to rent out their home or unit.

7. Property owners have to post their license number on Airbnb or other short-term rental websites along with their listing to rent their home.

8. Prior to the regulations going into effect, short-term rentals are technically illegal in the county. However, the county is currently taxing them and not actively shutting down short-term rentals that are taking place.

## Yard Sign Traffic Reminders


