Over the past several months, HCA has heard from residents on many issues--often having to do with zoning or housing code issues and police matters. Questions include: When is a building permit required? Are rental licenses needed? What businesses can be run from a home? How does the county handle enforcement problems? Is there a crime alert?

So, to answer your questions, our March meeting will provide a forum for residents to learn and ask question of Montgomery County housing/zoning investigators, and from the Silver Spring's Third District police.

The speakers include front-line personal that are tasked at providing the services we rely upon to make our neighborhoods strong. Housing Code Enforcement will discuss homeowners' responsibilities and rental licensing requirements. Zoning Code Enforcement will provide information on what is permissible in our R-90 zoned area, and what can be done to achieve compliance with county code. Our police speaker will be Lt. Robert McCullagh, Deputy Commander for the Silver Spring Police District, responsible for the H2 "beat" which includes most of Hillandale, Oakview and Long Branch. He will be able to discuss what's happening in our neighborhood and the surrounding areas.

The meeting will include reports on other HCA activities and provide ample opportunity for residents to discuss old and new business. Please attend, provide input and support for HCA activities.
