## Zoning Appeal Legal Fund

Hillandale's Administrative Appeal of the various permits issued by the Montgomery County Department of Permitting Services allowing the Unique Thrift Store and Bazaar to operate at the Hillandale Shopping Center was granted by the Board of Appeals in October. The Board's written decision is expected to be filed in December.

Legal fees incurred by HCA have been significant. Historically HCA has kept reserve funds for this type of situation. Because of the significance and expense of this appeal, community members have also contributed money over the past few months. We now need your help to replenish HCA's fund, both to complete the present case and to have reserves for any future need.
