#### **USPS Mail Collection Box Story....**

Many residents in West Hillandale neighborhoods have lamented the loss of the Postal Service's iconic blue collection mailboxes on their street corners. A request was recently made to HCA to see if this beloved, convenient service could be brought back to the neighborhood.

Jeff McNeil, HCA's VP, made inquiries and unfortunately, the collection boxes are gone for good. Postal officials studied the service before the removal and concluded that there was not sufficient usage, there were few reports of stolen outgoing mail from home mailboxes, and there are multiple collection boxes in the general area. These factors, combined with the diminishing financial resources of the Postal Service, and fact that the old metal boxes were recycled with a scrap metal dealer, mean that the decision is final.

USPS wants you to know you can place outgoing mail in your own mailbox for your carrier to pick up. And, the old familiar blue collection boxes remain at the Hillandale and White Oak shopping centers.

#### **Housing Code Questions** "Call 311 To Get It Done"

Montgomery County's Call 311 System has made it easier for residents to get information on any County service and bring individual concerns to the attention of appropriate authorities. HCA encourages residents to use this system to report any vacant home, or other property-condition concerns, (If 311 does not work from your phone, call 214-777-0311 to be connected.) **HCA's Role**

#### **New Parking Rules Take Effect**

Beginning on October 24, vehicles are no longer allowed to be parked on unpaved surfaces in the front yard. On-property parking must be on surfaced areas. Paving of a front yard has also been limited by recently enacted code. And finally, only one light commercial vehicle is permitted to park on-property.

#### HCA Crime Watch Updates: Thefts from Vehicles

Two spates of "thefts from vehicles" occurred in Hillandale recently. Along with residents having cars rifled, windows broken and GPS, DVDs stolen, another disturbing fact has become apparent—Victims are not reporting the incidents to the police. According to word-of-mouth and e-mail reports, it seems that **fewer than half of the crimes were reported to MCPD.** 

Although you may think that it is a waste of time to make the call, it is imperative that the police are informed of these petty crimes in our community. It is unimportant whether your car was unlocked, or if the items stolen were inconsequential – MCPD needs to know. Additional resources are only allocated when there is data to support the need, and if we are not reporting the problems, there is no apparent need.

Please remove valuables from your car—or lock them in the trunk. By making vehicles less attractive, the criminals will consider Hillandale less lucrative.

#### **Aggressive Roadside Solicitation**

Community members recently met with the Third District's H2 Deputy Commander, Lt. Elizabeth Hattenburg to discuss concerns pertaining to the roadside solicitation at New Hampshire Ave. and Powder Mill Road. Current State law allows for roadside solicitation from the sidewalk and medians, but not while standing on the road surface.

Lt. Hattenburg encourages drivers who experience aggressive or threatening solicitation to call the MCPD non-emergency number. Also if you see open public consumption of alcoholic/beer beverages, call the nonemergency number.

HCA has requested that outreach to the homeless in the area be done by the Department of Health and Human Services.
